- 1. The meeting was called to order at 7:10 pm by Chairman Bauer.
- 2. Minutes from the September 7, 2020 Board meeting were read with no additions or corrections. Motion by SSeidl, seconded by JBauer to accept the minutes as read, motion carried.
- 3. The Treasurer's report was distributed and bills approved for payment.

- 5. Assessor Update The Clerk contacted the Assessor regarding the Dept of Revenue Audit. The Clerk also asked if we could purchase some shelving for the store room along with file boxes for storing historical files. Both were approved with a motion by SSeidl, second by JBauer, motion carried.
